**Imports:** Transport of loaded containers from MICT CY/MPSEZ CY, stacked, placement for loaded containers for examination, de-stuffing & delivery on party's vehicle.

- IOPEPC Cargo certification charges will be Rs.2050/- per 20' & 4100/- per 40'.
- Incase of any bags packing will be less than 20 Kgs then it will be consider in Sr. No 03 slabs

### 1.2 Composite charges for Factory stuffed Export container & Loaded delivery of Import container

**• Composite charges include:**

**Export :** Lift off of loaded container from party's vehicle ,custom examination and after customs sealing transportation to MICT CY/MPSEZ CY

**Import :** Transportation of loaded containers from MICT CY/MPSEZ CY to CFS, Lift off and placing containers for examination and lift on of loaded container on party's vehicle.
